The committee inspected the college on 27.11.2021. Following are the observations of the committee:

1. **Infrastructure and Amenities:** The College has sufficient number of Class-rooms, Library, Moot-Court room, Legal Aid room and other infrastructural facilities. The college has adequate number of furnished tutorial rooms, separate common rooms for boys and girls, there are sufficient number of rooms for teaching faculty and non-teaching staffs.
2. **Administrative Staff:** The College has adequate numbers of non-teaching staff and also approved by M.D. University, Rohtak.
3. **Teaching Faculty:** The South Point College of Law has one Principal/Director and 14 Assistant Professor in Law and 04 Assistant Professor in Pre-Law teachers.
4. **Academic Requirements:** The College fulfils the academic requirements to a larger extent. The college has a computer lab and Library. The college also has an Internet facility. The college has 6440 number of books. In the last academic year, the college added 438 books for LL.B and LL.M classes in the Library. The college is in process of obtaining approval from the BCI.




Recommendations:


The South Point College of Law may be granted extension/continuation in provisional affiliation for LL.B (Hons.)-3 Year and B.A.LL.B(Hons.)-5 Year with an intake of 120 seats in each Course LL.M course with an intake of 30 seats for the session 2021-22 subject to the following conditions:


1. The college must purchase books prescribed in University syllabus for LL.B/LL.M worth Rs. 80000/- for the library.
2. During the inspection, majority of the teachers including Principal was found absent and this is very shocking for the inspection committee.
3. Moot Court Hall is temporarily arrange by the College/Management and this is the serious default at the part of college/management.
4. Record of the Legal-Aid-Clinic not maintained according to academic standard.
5. Approval of LL.M may be granted subject to appointment of minimum two Associate Professor and One Professor by a duly constituted selection committee by the University.
6. No Legal Data Base found in the college so it is directed to buy minimum one legal data base of multi user.
7. One Toilet should be provided at ground floor for the physically challenged persons.
8. Proper CCTV surveillance should be provided in the entire campus of the college.


