(Hons.) 3 year Program with an intake of 180 seats, B.A.LL.B. (Hons.) 5 year program with an intake of 120 seats subject to the approval of the Central Body i.e. Bar Council of India, New Delhi. The Vice-Chancellor has also allowed to grant extension/continuation in provisional affiliation in existing LL.M. Program with an intake of 30 seats for the session 2025-26 to your College.

The above extension/continuation in provisional affiliation is granted with the condition to strict & timely compliance of the deficiencies as pointed out by the Inspection Committee and to submit the compliance report well before the commencement of academic session 2025-26. The College may be further asked to comply with the instructions of Bar Council of India, New Delhi.

**Sub:** Checking of compliance report-matter regarding grant of extension/continuation in provisional affiliation for LL.B (Hons.)-3 Year with an intake of 180 seats, B.A.LL.B (Hons.)-5 Year course 120 seats and LL.M programme with an intake of 30 seats for the session 2025-26 at South Point College of Law, Rattangarh-Baghru, Gate No. 1, Gohana Road, Sonapat.

A committee consisting of the following was constituted vide letter no. CB-II/407/2024/17678-80, dated 13.12.2024 for the aforesaid purpose:

1. Prof. K.P.S. Mahalwar (Retd.), Department of Law, MDU Rohtak
2. Dr. Yogender Singh, Associate Professor, Department of Law, MDU Rohtak
3. Dr. Neelam Kadyan, Associate Professor, Department of Law, MDU Rohtak

The committee inspected the college on 19.01.2025. Following are the observations of the committee:

1. **Teaching Faculty:** The South Point College of Law has 40 teaching staff including Principal. Out of total teaching faculty, 25 teachers including Principal are duly approved by the University, proceedings of 05 teachers are approved by the University and 10 teachers are eligible/qualified [02 Professor (Retd.) for non-law subjects, 02 Associate Professors for Law subjects and 06 Assistant Professors (one for Law subject, 02 for non-Law Subjects, 01 TPO, 01 for Physical Education and 01 for Computer Application)]. However, five teachers were on leave on the day of Inspection.
2. **Administrative Staff:** The College has total 30 non-teaching staff and all are approved by M.D. University, Rohtak except one.
3. **Infrastructure and Amenities:** The College has 21 Class-rooms (including two smart class-rooms), Library with reading hall, Moot-Court room, Legal Aid room, Seminar Hall and other infrastructural facilities. The college has adequate number of furnished tutorial rooms, separate common rooms for boys and girls, cafeteria, First-Aid-cum-Sick room and there are sufficient number of common rooms for teaching faculty and non-teaching staffs.
4. **Academic Requirements:** The College fulfils the academic requirements to a larger extent. The college has well equipped computer lab with 30 computers and 06 printers. The South Point College of Law has a well furnished Library with E-

database Manupatra and DELNET (due for renewal on February 16, 2025). The college also has an Internet facility. The college has purchased in the last academic year only 58 books for LL.B/LL.M course. However, the College submitted the purchase bill of 152 books.


5. The College has a Governing Body/Board of Governors duly approved by M.D. University, Rohtak
6. The college is not accredited by NAAC/NBA.
7. The college principal has submitted an undertaking that there is no CM/PM grievance related to salary of the staff pending.
8. The College has BCI approval for BALL.B 5 Year course and LL.B 3 Year Course for the academic year 2024-2025. intake

9. The college principal has submitted a copy of the inspection report of the previous inspection committee. However, no deficiency was pointed out by the previous inspection committee.


#### Recommendations:


