This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently."

Since your university has given affiliation for the year 2018-2019, you are requested to allow **South Point College of Law, Sonipat** to admit students in **three year LL.B as well as five year BA LL.B law courses** with existing sections for the academic year 2018-2019.

Note - (1) That w.e.f 21.05.2016 the inspection fee for LL.B three year and five year regular course is Rs. 3 lacs for each course and for the Honours course it is Rs. 5 lacs, while the application fee is Rs. 50,000/- and the guarantee amount is Rs. 5 lacs.
